 - 5)The undersigned agrees to notify the Company by certified mail of any change in ownership and further agrees to be liable for all purchases should the undersigned fail to comply with said notification. In the event more than one person executes this guarantee, the liabilities and obligations of the undersigned shall be joint and several and the words herein shall be read as if written in the plural.
 - 6)The undersigned hereby consent(s) to the Company having the option to obtain, at their discretion, a non-business consumer credit report on the undersigned in order to evaluate the credit worthiness of the undersigned as a principal, proprietor, or guarantor of applicant in connection with the extension of business credit contemplated by the execution and submission of this document. The undersigned authorizes the Company to obtain additional credit reports as deemed necessary to update and evaluate account.
 - 7)In the event suit must be instituted to collect, the undersigned purchaser hereby agrees that jurisdiction shall lie in the courts of the state of Florida and venue shall be proper in Broward County, Florida.
